The American Legion's interest in Immigration and Naturalization focuses on the security and protection of our Nation's borders, the assimilation of immigrants into American society, immigration quotas, and citizenship and naturalization matters.

The Americanism Commission works closely with the Legislative Commission to review all legislation affecting these subjects.

The American Legion is unalterably opposed to illegal immigration and the granting of amnesty to any and all illegal aliens.

The American Legion supports rigid enforcement of employer sanctions as called for in current laws that provide penalties for employers who knowingly hire illegal aliens.

The American Legion supports a temporary workers program for certain industries that face persistent and/or seasonal labor shortages, but supports the establishment of a numerical quota established and under the control the appropriate government agency.

The American Legion insists that legal immigrants be admitted in such numbers that can be readily absorbed into the life stream of America and would not displace veterans from either employment or housing.
